

MOBILTRON PARENTAL CONSENT FORM

Direct Notice to Parents

In accordance with the Children’s Online Privacy Protection Act, (www.COPPA.org) parents and legal guardians of children under 13 years of age must consent to certain collections, uses and disclosures of the personal information of their children collected by Mobiltron, Inc. Please consult the user manual and privacy policy for your child’s Devices for information about the types of information collected by the Devices.
